Where's the reef?

Tons of concrete take the plunge off Doctors Pass

Artificial reefs are a critical component in building a healthier environment for Southwest Florida's marine life. In addition to increasing reef fish habitat, artificial reefs improve recreational and charter fishing and diving opportunities, providing a socio-economic benefit to the community and facilitate reef research.

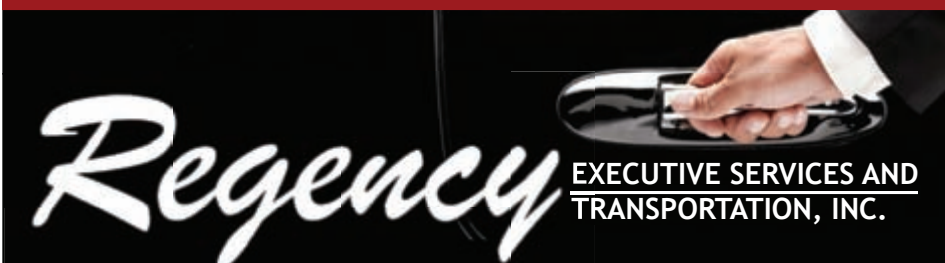
Collier County boasts more than 100 offshore artificial reefs. That number has increased by one with the deposit of 430 tons of concrete culverts, junction boxes and other acceptable secondary

concrete materials 30 feet below the Gulf of Mexico surface 4.5 miles off Doctors Pass.

The load dropped Thursday, June 25, at latitude 26.10.260/longitude 81.54.060 was the first of two that will comprise the county's newest reef. The second, a load of about 520 tons, was set to make a splash on Monday, June 29, but high winds and seas forced its cancellation. A new date had not been set as of press time.

"The materials will not only create a healthy habitat for our very important
